What is APA 7th?

The "APA style" is an author-date style for citing and referencing information in assignments and publications. This guide is based on the "Publication Manual of the American Psychological Association" 7th edition (2019).

About referencing

This referencing style guide provides a set of rules on how to acknowledge the thoughts, ideas, and works of others when you use them in your work.

Many types of publication examples have been provided in this guide. If you cannot find the example you need, you can:

- consult the Publication Manual of the American Psychological Association (7th ed.) or APA Style
- view the reference lists of articles in publications that use APA such as American Psychological Association journals (check which APA edition was used)
- consult the **Instructions to authors** if writing for a journal
- adopt the rules of a similar publication type to the item
- consult other institutions' style guides
- consult with your tutor or course coordinator.

In-text references

Using in-text references

- **No specific font type or size is required**. Recommendations include Calibri size 11, Arial size 11, Lucida size 10, Times New Roman size 12, Georgia size 11, or Computer Modern size 10 (LaTeX).
- The last name of the author(s) and the year of publication are generally needed.
- They can be part of a sentence (**narrative**) e.g., Thompson has argued that "...." (2018) or included within parentheses or brackets (**parenthetical**) e.g. (Thompson, 2018).
- They can appear within a sentence or at the end of a sentence before the full stop e.g., this week (Johns, 2017).

- A **page number** is included for a direct quote. Place a comma after the year and use p. for single page, pp. for multiple pages e.g. (Harris, 2012, p. 164) or (Lewis, 2016, pp. 56-58).
- When you **paraphrase** or refer to an idea from another work, a page number is not required. However, it can be useful to include.
- If there is **no date**, the abbreviation **n.d.** may be used e.g. (Harris, n.d.)
- if work is **not yet published**, use **in press** e.g. (Taylor, in press).

(First author - first name initial. last name, Year)

First author - first name initial. last name (Year)

(First author - first name initial. last name & second author - last name, Year)

First author - first name initial. last name and second author - last name (Year)

Example

- (J. P. Lewis, 2007)
- J. P. Lewis (2007) argues that....
- (R. Lewis, 2007)
- R. Lewis (2007) stated that...
- (S. Lewis & Edwards, 2015)
- S. Lewis and Edwards (2015) found that

Include each first author's initials in all citations. Do this for the first author only.

If the same author's last name is found as second, third etc. authors, initials are NOT used.

Initials of first author are included even if year of publication differs.

Works with same author(s) and same year

- Place an a, b, c etc. after the year
- The letters are allocated in the reference list where references with the same first author last names are organized alphabetically by title. The first reference listed uses "a", second uses "b" etc.
- If "in press" is used for the year, place dash between "press" and relevant letter e.g., in press-c
- Use each time the references are included. This includes for a single reference within a parentheses or multiple works in same parentheses.

Examples:

(Jordan & Kendall, 2010a)

(Jordan & Kendall, 2010b)

(Jordan & Kendall, in press-c)

(Jordan & Kendall, 2010a; Harris, 2018)

Work with no author(s) or editor(s)

In-text reference

Format

("First words of article, chapter title" - in title case, Year)

"First words of article, chapter title - in title case" (Year)

(Title of book, journal - in title case, Year)

Title of book, journal - in title case (Year)

Example ("Social Media", 2013) "Social Media" (2013) (Social Media Security, 2014) Social Media Security (2014)

Use **double quotation marks** "...." and **title case** (capitalize each word) for title of article, chapter, or web page with no author.

Italicize title of journal, book, brochure, or report with no author. Use title case.

Use title case for in-text references only.

Multiple works within same reference

Two or more works by different authors

- List works alphabetically (as they appear in the reference list)
- Separate references with a semicolon.

Example:

(Noble et al., 2015; Walker, 2011)

Two or more works by the same author

- Order references by year of publication
- Put n.d. (no date) references first
- Put "in press" references last
- Only use the author's last name or groups name once then list the years

Examples:

```
(Lewis, n.d., 2012, 2015, 2016, in press)
(Education Queensland, 2011, 2013)
```

(Education Queensland, 2011; Lewis, 2012, 2015, 2016, in press)

Two or more works by the same author published in the same year

- Place an a, b, c etc. after the year
- The letters are allocated in the reference list where references with the same first author last names are organized alphabetically by title.

- Repeat each year with each letter used e.g., 2018a, 2018b, 2018c
- If "in press" is used, place dash between "press" and relevant letter e.g., in press-c
- Use this format each time the references are used in-text.

Examples:

(Jordan & Kendall, 2010a)

(Jordan & Kendall, 2010a, 2010b, in press-c)

(Jordan & Kendall, 2010a, 2010b; Mitchell & Clarke, 2004; Tourism Queensland, 2009)

Works that are reissued, reprinted, republished, or translated

- Both the original year and the reissued, reprinted, republished, or translated year of the work needs to be included.
- The years are separated by a forward slash /.
- The original year is listed first.

Example:

(Austen, 1813/2015)

Austen (1813/2015)

Direct quotations

What is a direct quotation?

A direct quotation reproduces word-for-word material taken directly from another author's work, or from your own previously published work.

If the quotation is **fewer than 40 words**, incorporate it into your paragraph and enclose it in double quotation marks. Place the in-text reference before the full stop.

David Copperfield starts with "Whether I shall turn out to be the hero of my own life, or whether that station will be held by anybody else, these pages must show" (Dickens, 1869, p. 1).

If the quotation **comprises 40 or more words**, include it in an indented, freestanding block of text, without quotation marks. At the end of a block quotation, cite the quoted source and the page number in parentheses, after the final punctuation mark.

Whether I shall turn out to be the hero of my own life, or whether that station will be held by anybody else, these pages must show. To begin my life with the beginning of my life, I record that I was born (as I have been informed and believe) on a Friday, at twelve o'clock at night. It was remarked that the clock began to strike, and I began to cry, simultaneously. (Dickens, 1896, p. 1)

Format of a direct quotation in-text reference

- Include the author, year, and specific page number for that quotation.
- For material without page numbers, give the paragraph number or a time stamp.
- Include a complete reference in the reference list.

Examples:

```
(Smith, 2003, p. 105)
(Brown, 1999, pp. 49-50)
Smith (2003) has argued that "....." (p. 105)
As Brown (1999) found "....." (pp. 49-50)
(Anderson, 2019, 2:17)
Anderson (2019) noted that "...." (2:17)
```

Placement of a direct quotation in-text reference

• If the direct quote is part of a sentence, place the in-text reference directly after the quote and continue with the sentence. For example: -

Mindfulness has a range of meanings as it "has become a trend word conveying a diversity of understandings dependent on context" (Crane, 2017, p. 586) and can encompass....

As Crane (2017) said, "Mindfulness has become a trend word conveying a diversity of understandings dependent on context" (p. 586) and can encompass....

• If the direct quote is at the end of a sentence, include the in-text reference directly after the quote and end with a full stop.

"Mindfulness has become a trend word conveying a diversity of understandings dependent on context" (Crane, 2017, p. 586).

Quoting audiovisual works

• Add a **time stamp** in place of a page number when quoting from audiovisual works such as videos, songs, TV shows.

Example:

```
(Yates, 2019, 1:14)
(Henderson, 2017, 2:30:14)
```

Works without a page number

For works without a page number, you can add: -

- paragraph number (manually count if not listed) e.g., (Kennedy, 2019, para.8)
- heading or section name e.g., (Harris, 2018, Behaviour Therapy section)
- act, scene, and line(s) for plays e.g., (Wilde, 1895/1997, 1.1.6-8) (means Act 1. Scene 1. Line(s) 6-8)
- canonically numbered sections for religious or classical works e.g., (Genesis 15:6) (include book, chapter, verse, line, or canto in place of page number)

Reference list

Reference list formatting

- No specific font type or size required. Recommendations include Calibri size 11, Arial size 11, Lucida size 10, Times New Roman size 12, Georgia size 11 or Computer Modern size 10 (LaTeX).
- The reference list is **double spaced** (between each reference AND within the reference).
- A reference list is **arranged alphabetically by author last name**.
- Each reference appears on a new line.
- Each item in the reference list is required to have a **hanging indent**.

- References should not be numbered.
- If a reference has no author, it is cited by title, and included in the alphabetical list using the first significant word of the title.
- If you have more than one item with the same author, list the items chronologically, starting with the earliest publication.
- If there is no date, the abbreviation **n.d.** may be used.
- Use the **full journal name**, not the abbreviated name.
- Web addresses or DOIs can either be live links (blue and underlined) or as normal black text with no underline. If the work containing the reference list is to be made available online, use the live link format.

Difference between reference list and bibliography

- A **reference list** only includes the books, articles, and web pages etc. that are cited in the text of the document.
- A **bibliography** includes all sources consulted, even if they are not cited in the document

Titles

- Article or book chapter titles
- o use **sentence case** (the first word uses a capital letter with each subsequent word in lower case). The exceptions are for names e.g., countries and after a colon: e.g., Writing prose in Australia: Words of wisdom from the best
- o do not use single or double quotation marks.
- do not italicize.
- Books (including when using book chapters) and reports titles
- use sentence case
- italicize the title
- Journal, magazine, and newspaper titles
- should be provided in full (not abbreviated) and use capitals where appropriate (rather than sentence case) e.g., Psychological *Review*.
- they should be **italicized**.
- Website titles should be italicized.
- No title
- add a description of the reference used, including the type of reference in square brackets. For example, [Image of a child playing in outdoor playground].
- For **social media posts or comments without a title**, add up to the first 20 words used in the post or comment and **italicize** it. Also include a description of the work in square brackets. For example, *On Monday and Tuesday* (16-17 December) this week, we are replacing computers in the PACE Health Sciences Library [Infographic].

Order of works with no title

• Author, A. A., & Author, A. A. (Year of Publication). [Description of source] Format the remainder according to resource type.

For example,

Smith, F. (2018). [Corpus of Amazon reviews for qualitative coding project]. Unpublished raw data.

Publisher details

- List multiple publisher names in the order in which they appear, separated by semicolons.
- For publisher names, words like "Co.", "Publishers" or "Inc." should not be included. For example, use Springer, not Springer Publishers.
- Places of publication are **not** included.
- Do not include publisher name if it is the same as the author.

Publication date

- Use **n.d.** if there is no date available
- Use **in press** when the work is accepted for publication but has not been published
- When the work has been **published online prior to publication**, include the year of when it was added online.
- When a month, date or season is used, use (Year, Month Date) or (Year, Season). For example, (2019, November 8) or (2019, Autumn/Winter).
- If a "Last Updated" date in used, include this as the publication date. This is only when the information has been clearly changed, not just reviewed.
- For online works that are meant to be changed regularly e.g., Facebook, dictionary entry, use Retrieved Month, Date, Year, from Web address. For example, Retrieved November 8, 2019, from https://www.facebook.com/uniofqldlibrary

Page numbers

- Use the full-page range and full-page numbers e.g., 121-138
- For an online publication that uses **article numbers** or similar, include **Article then the article number** in the Page Number place. For example, Article e09645731
- Page numbers are included when you are referring to a section of a greater work e.g., book chapter, journal article.
- Use pp. for **book chapter** page numbers but not for journal articles.

Multiple works with same author(s) and same year

- Arrange works with the same author(s) and same year **alphabetically by title** in the reference list. This then determines which references uses a, b, c etc.
- Add the relevant letter after the year (which is also used for corresponding in-text references). The first reference listed in the reference list uses "a", second uses "b" etc.

- If the date is **n.d**. (for no date), include a dash then the relevant letter at the end e.g., n.d.-a. It will appear before any specified years.
- If the date is "**in press**", include a dash then the relevant letter at the end e.g., in press-a. It will appear after any specified years.
- If a month and day are included, references with just a year are first, followed by specified dates in chronological order. For example: -

(Taylor, 2019a)

(Taylor, 2019b, May 14)

(Taylor, 2019c, August 3)

• This applies to **all reference types** with the same author(s) and year.

Format	Cite the last names & initials of the first 19 authors then follow with a comma and three spaced ellipsis points (), then the last author's name.
Example	Nath, A. P., Ritchie, S. C., Grinberg, N. F., Tang, H. H., Huang, Q. Q., Teo, S. M., Ahola-Olli, A. V., Wurtz, P., Havulinna, A. Using headings

Tips on using headings

- There are five levels of headings
- All headings work from the top level down, regardless of how many subheadings in the section
- Each section begins with the top-level heading, regardless of how many subheadings are used within the section
- **Do not** use numbers or letters as labels in headings

- **Do not** use Introduction as your first heading
- The **title of the paper** is not considered a heading.
- Place the title at the top of the first page
- Use regular font in **title case** (all words except words like and, to, a, they are capitalized. These words are capitalized if first word in title).
- **Bold** and **center** the title.

- If the book does not have chapters written by different authors, you only need to reference the book.

Referencing figures

- Each figure needs to be numbered in the order in which they appear in the document.
- If a figure is being reproduced for inclusion in a work which is being published, you must seek permission from the copyright holder. This permission must also be included in the caption.
- Provide each figure with a brief but explanatory title. This should appear next to the figure number.
- A caption should be included the bottom of the figure to acknowledge that the figure has been reproduced from another source.
- Include the full reference in the reference list.
- Examples of figures with copyright attributions.

What is an indirect citation or secondary source?

An indirect citation or secondary source is when the ideas of one author are published in another author's text, but you have not read or accessed the original author's work.

- Include both the original author and year and the author and year of the work where quote/idea was found in the in-text reference.
- Add "as cited in" before the author in the in-text reference. For example (Harris, 2009, as cited in Lewis, 2019).
- In the reference list, provide the details of the work in which you found the quotation or idea.

When do I reference software or apps?

- Software or apps that are common (to your field or audience) do not need to have in-text references and reference list entries. Just include the full software or app name and the version in brackets (if relevant). For example, Covidence (Version 2).
- If they have limited access or distribution, the in-text reference and reference list entries are required. Please see the examples below.
- If you have quoted or paraphrased from software or an app, they also need to use an in-text reference and include a reference list entry.
- If you used a website to create something like a survey, include the website name and address in text. For example We used Checkbox (https://www/checkpoint.com) to create our survey. An in-text reference and including a reference list entry isn't required.

- Each table needs to be numbered in the order in which they appear in the document e.g., Table 1, Table 2.
- Always refer to a table by their number. Statements such as "in the table below" or "the table shown on page 78" should not be used.
- Provide each table with a brief but explanatory title. This should appear below the table number.
- A table note (caption) should be included the bottom of the table to acknowledge that the table has been reproduced from another source.
- If a table is being reproduced for inclusion in a work which is being published, you must seek permission from the copyright holder. This permission must also be included in the table note (caption). The word "Note" is included at the start in italics.
- "Note" is used in place of in-text reference.
- Include the full reference in the reference list.
- Check out some table examples.

- If referring to a website in general, do not include it in the in-text reference or in the reference list. Include website name within the text and add the web address in parentheses. For example The survey was developed using Checkbox (http://www.checkbox.com)
- Leave out the name of the website if the author and site name are the same.
- If a part of the date is not available e.g., not specific date e.g., March 16 or no month, just include the year.

 - The University of Queensland. (2020, October).
 - The University of Queensland. (2020, October 15). If there is no date at all, include n.d.
- If there are references with the same author(s) and year, list them in alphabetically by title in the reference list. For the first of these references, add "a" after the year, b after the year for the second reference and so on. Use the relevant letter after the year in the in-text reference.

This guide will help you set up an APA Style student paper. The basic setup directions apply to the entirepaper. Annotated diagrams illustrate how to set up the major sections of a student paper: the title page or cover page, the text, tables and figures, and the reference list.

Basic Setup


Seventh edition APA Style was designed with modern word-processing programs in mind. Most defaultsettings in programs such as Academic Writer, Microsoft Word, and Google Docs already comply with APA Style. However, you may need to make a few adjustments before you begin writing.

- Margins: Use 1-in. margins on all sides of the page (top, bottom, left, and right).
- Font: Use a legible font. Many fonts are acceptable, including 11-point Calibri, 11-point Arial, 12- point Times New Roman, and 11-point Georgia. The default font of your wordprocessing programis acceptable.
- Line spacing: Use double-spacing for the entire paper (including block quotations and the
 referencelist). Do not add blank lines before or after headings. Do not add extra spacing
 between paragraphs.
- Paragraph alignment and indentation: Align paragraphs of text to the left margin. Leave the rightmargin ragged. Do not use full justification. Indent the first line of every paragraph of text 0.5 in.using the tab key or the paragraph-formatting function of your word-processing program.
- Page numbers: Put a page number in the top right corner of every page, including the title page orcover page, which is page 1. Student papers do not require a running head on any page.







Advising Psychology Majors About Graduate School in Psychology: Current Practices and Challenges

Introduction

The APA Guidelines for the Undergraduate Psychology Major outlines strategies for psychology departments to help students discern and take steps toward their professional development goals (APA Board of Educational Affairs Task Force on Psychology Major Competencies, 2013). For many students, graduate school is fundamental to achieving postbaccalaureate success. High-quality advising can be vital in helping students gain admission to psychology graduate programs. However, little is known about the strategies that psychology departments use to advise students about graduate school. We conducted the present research to better understand these strategies.

The job outlook for psychology majors who earn graduate degrees is quite good. In fact, the demand for psychologists with graduate degrees is expected to grow much faster than the demand for



- Sections and headings vary depending on paper type and complexity.










Placement of Tables and Figures

You can embed tables and figures in the body of the paper.


This guide shows options for placement. If your instructor requires tables and figures to be placed at the end of the paper, see examples in the *Publication Manual* and in the professional sample paper on the APA Style website.

- Embed tables and figures in the text.
- Call out (mention) the table or figure in the text before embedding it.
- Place the table or figure after the callout
 - o at the bottom of the page
 - o at the top of the next page
 - by itself on the next page
- Avoid placing tables and figures in the middle of the page.

Callout in text before table or figure

Table 1 presents responses to the question regarding formal requirements for students to learn about graduate school in participants' home departments. A little more than a third of departments required students to complete a careers or professional development course or course module(s) that included information about graduate school, and 25% of departments required that students meet with a department advisor about graduate school. Forty-eight percent of participants indicated that their department had no formal requirements for students to learn about graduate school.







Final Checks

Check Page Order

- Start each section on a new page.
- Arrange pages in the following order
 - Title page (page 1)
 - Text (starts on page 2)
 - Reference list (starts on a newpage after the text)



Check Headings

- Check that headings accurately reflect the content in each section.
- Start each main section with a Level 1 heading.
- Use Level 2 headings for subsections of the introduction.
- Use the same level of heading for sections of equal importance.
- Avoid having only one subsection within a section (have two or more, or none).

Check Assignment Instructions

- Instructors' guidelines supersede APA Style.
- Students should check their assignment guidelines or rubric for specific content to include in their papers and to make sure they are meeting assignment requirements.

Tips for Better Writing

- Ask for feedback on your paper from a classmate, writing center tutor, or instructor.
- Budget time to implement suggestions.
- Use spell-check and grammar-check to identify potential errors.
- Proofread the paper by reading it slowly and carefully aloud to yourself.
- Consult your university writing center if you need extra help.
